Freshmen and sophomore waitlisted readmits will be given priority. The remaining readmitted students will be offered if and wherspace becomes available in date order.

Those who are eligible to complete the housing tract, within the designated time will be guaranteed on campus housing during the following ar.Students not bound by the residency requirement (rising juniors/seniors) who fail to complete a contract during the renewal period will be placed on the waiting list.
